

Contest Rules

The earthday365 “Pandemic Getaway” Raffle is a fundraising raffle to support the organization’s sustainability efforts with 100% of the money raised through the Raffle going to support these efforts. You can learn more about our Mission and Program by visiting our website: www.earthday-365.org.

The Raffle is conducted in the state of Missouri, the state where earthday365 is based, and is open to participants who are at least 18 years of age at the time of purchase and who are a permanent resident of the 48 contiguous states in the United States. Employees and members of their immediate family are not eligible to participate. The Raffle is being conducted and governed pursuant to Missouri law.

1. Tickets can only be purchased in the state of Missouri via the internet at www.earthday-365.org/raffle-tickets/ and all tickets are considered sold in Missouri when purchased. By purchasing a ticket, each participant agrees to be bound by and adhere to the terms and conditions contained in these Rules.
2. You may participate by purchasing as many raffle tickets as you wish. However, only 1,000 tickets will be sold. We will send a confirmation of your purchase to the email address you provide. We are not responsible for any lost or misdirected email. If you do not receive your ticket purchase confirmation via email within 24 hours after purchase, you should contact us by email at info@earthday-365.org or call us at 314-282-7533.
3. The deadline to be eligible for the drawing is to purchase a ticket or tickets before 1,000 tickets are sold or by April 22, 2021 at 11:59 pm, unless extended, whichever comes first. A ticket is “sold” for purposes of calculating the number of tickets sold when earthday365 receives full payment for that ticket. Anyone attempting to buy a ticket after 1,000 tickets have been sold will have their purchase fully refunded. Except for refunding the purchase, we are not responsible if your purchase cannot be processed because we have already sold 1,000 tickets, or if your payment arrives after 1,000 tickets have been sold, or your payment arrives after the deadline for purchase.
4. The winners are determined by a random drawing to take place at 4125 Humphrey St., St. Louis, MO 63116 at earthday365’s offices via livestream on April 23, 2021 at 2:30 pm. The location, date, and time will also be posted on the website: www.earthday-365.org/raffle-tickets. You are welcome to observe the drawing via live stream on earthday365’s Facebook page. The winners do not have to be present, physically or virtually, at the drawing to win.
5. There are three prizes:
 - a. The grand prize is a two night stay in a charming two-bedroom house in historic Elsah, IL plus a \$50 Gift Certificate to Old Bakery Beer Company in Alton, IL. Total prize value: \$550. Located on the Great River Road, Elsah has been voted Illinois’ top scenic spot by voters of the Illinois Top 200 Project. Nestled in the bluffs of the Mississippi River, this quaint little village was the first village in its entirety to be placed on the National Register of Historic Places in 1973. Once an important steamboat landing, Elsah is better known today for its picturesque beauty, stone houses and lush gardens. The cottage has two queen beds plus large couch, full kitchen, parking on site, and wifi. It is located a short walk from the center of town. Nearby amenities include: many terrific country walks; bicycling The Great River Road; Pere Marquette State Park; Two Rivers National Wildlife Refuge; bar-hopping in Grafton or Alton. Canoe available. Winter is

prime bird-watching season for pelicans, swans, and eagles. This prize must be claimed by April 22, 2022. Donor: Dan Jay and Mary Ann Lazarus.

- b. The second prize is a two-night stay plus BBQ at Possum Hollow Cabin outside of Leasburg, MO, 70 miles from St. Louis (Value: \$540). The cabin is one large room and sleeps 4, with a queen bed and bunk beds. It includes a sitting area with futon, kitchenette with sink, under-counter refrigerator and microwave, dinette table, and full bath. It is fully equipped with towels, linens, kitchen utensils, and coffeemaker. It also has a patio with benches, two Adirondack chairs, patio table for four, and Weber charcoal grill. It overlooks an 80 acre lake, perfect for fishing, boating, and swimming. Guests will have access to a canoe, kayak, and small fishing boat. Access miles of private trails on 600 wooded acres with meadows, glades and ponds developed in conjunction with MDC's wildlife habitat improvement program. Check in should be anytime after lunch on Friday and check out anytime Sunday afternoon. The donors live in an adjacent home and have offered to host a BBQ for the winner if requested.

Possible excursions include Onondaga Cave State Park, and/or the Meramec River (both a mile away); RS Ranch for horseback riding (10 miles); or Meramec Springs State Park (20 miles). August 2021 dates are excluded. Prize must be claimed by April 22, 2022. Donor: John & Mary Risberg.

- c. The third prize is a one night stay at St. Louis Union Station; 6 Combo Tickets offering access to the St. Louis Aquarium, The Wheel, Carousel, Mini Golf, Ropes Course, and Mirror Maze; two stuffed animals; and two Aquarium t-shirts sized L & XL (Prize Value: \$536). A historic hotel. A sky-high ride. A sweet treat. A splashy surprise. Union Station is all these things and more. From family fun to a night out with friends, adventures await you at St. Louis Union Station! Prize must be claimed by April 22, 2022. Donor: St. Louis Aquarium Foundation.

6. The winners will be notified by email and/or phone and all participants will be notified of the winners on our website: www.earthday-365.org/raffle-tickets. A winner will be disqualified if the winner cannot be reached after a reasonable effort has been extended, is determined to be ineligible, or cannot or does not comply with our Official Rules. earthday365 will have made a reasonable effort to reach a winner if it has made at least two attempts to contact the winner via phone or by the email address provided when purchasing his/her ticket. If a winner is disqualified or declines acceptance of the prize, earthday365 will redraw to identify another winner for that prize. All winners agree and consent to disclosure of their identity and use of photographs or images of them with their prizes for promotional use.
